



BROOKSHIRE'S FROZEN FOOD MONTH SWEEPSTAKES

CUSTOMER OFFICIAL RULES

NO PURCHASE NECESSARY

1. **HOW TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN.** The Brookshire's Frozen Food Month Sweepstakes ("Sweepstakes") begins on Wednesday, 3/6/2019 and ends on Tuesday, 4/2/2019. Each time you purchase at least twelve dollars (\$12.00) (excluding sales tax) in selected frozen foods items (as listed in an attachment to these Official Rules, "Frozen Foods") in a single transaction at any Brookshire's Food Stores location (a "Brookshire's Store Location") using your Brookshire's Thank You Card ("Thank You Card"), you will receive one (1) entry in the Sweepstakes. Limit one (1) Sweepstakes entry per single transaction with at least twelve dollars (\$12.00) (excluding sales tax) of Frozen Foods included. You must be a registered user ("Registered User") of the Thank You Card in order to participate in the Sweepstakes or win a prize. Applying for a Thank You Card and registering is free – just visit any in-store kiosk at participating Brookshire's Food Stores, get a new card online by registering at http://www.brookshires.com/user_info#/register, or register through the Brookshire's app available in the App Store or Google Play.
